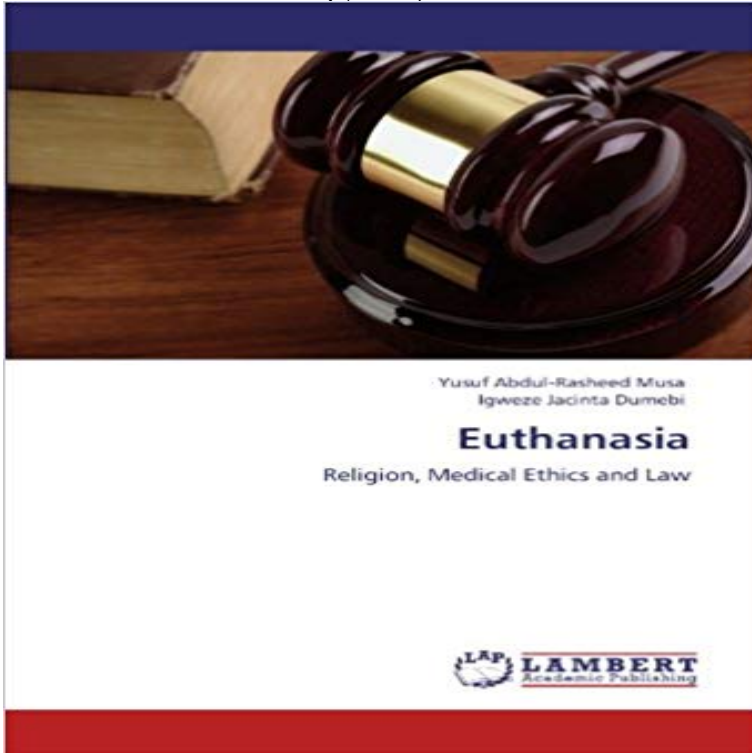


## Euthanasia: Religion, Medical Ethics and Law
