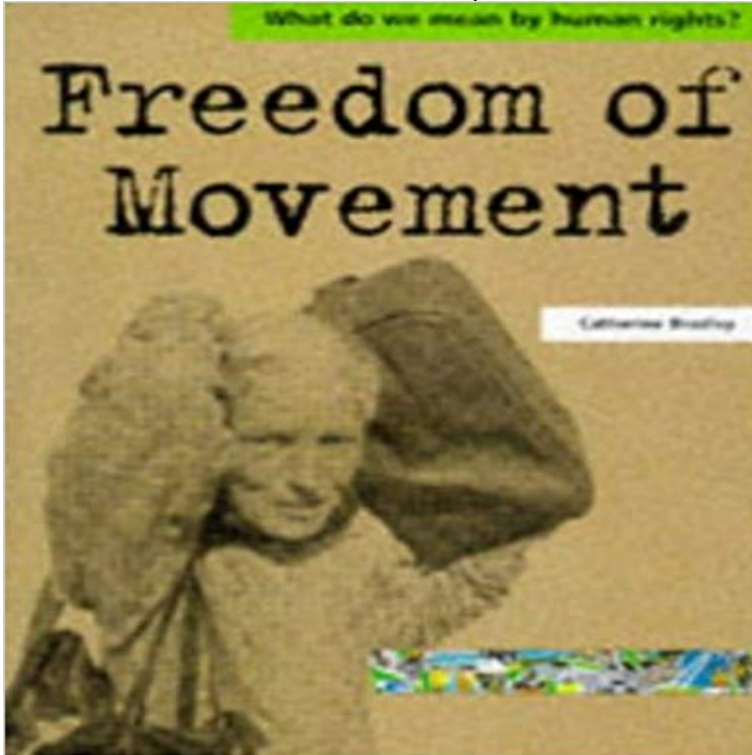


Freedom of Movement (What Do We Mean by Human Rights?)
